

FASTag Electronic Toll Collection

- FASTag is simple to use, reloadable tag which enables automatic deduction of toll charges and lets you pass through the toll plaza without stopping for the cash transaction
- FASTag is linked to a prepaid account from which the applicable toll amount is deducted
- The tag employs Radio-frequency Identification (RFID) technology and is affixed on the vehicle's windscreen after the tag account is active

- Registration Certificate (RC) of the vehicle.

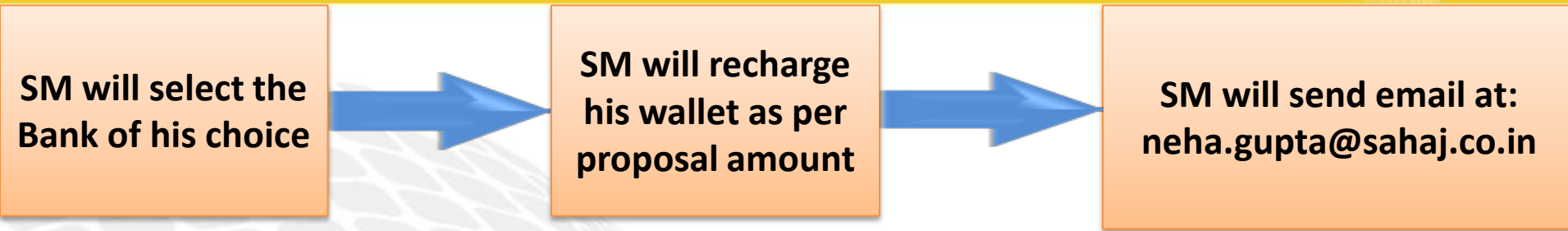
