Frequently Asked Questions



What is the next process after filling up the form successfully?

CA from tax2win will call the customer i their mobile number within 1-3 days and file your Income Tax Return.

What documents need to be taken from client?

You need to scan and upload the following documents:

PAN Card (it should be properly visible)

Form 16 (if client is a salaried person)

Does the SM need to keep any documents of the client with himself?

No, the SM doesn't need to keep any documents. As soon as they are scanned and uploaded, SM can give them back to their clients.

What does 'Source of Income' mean on portal?

It means the sources from where the client is earning his/her income. SM should confirm the same from his client and mark **YES/NO** accordingly.

Frequently Asked Questions



Is it necessary to give bank account details?

Yes. To file ITR, client has to give bank account details like Bank Name, IFSC and account number. Uploading the bank statement is not compulsory.

How much time does it takes for TDS refund?

Refund will be deposited directly in your bank account within 40-45 days of return filing.

What to do, if ITR is not filed even after making the payment?

The amount will be refunded within 7 working Days. SM can mail at support@sahaj.co.in

Where can I get ITR-V?

Either from your registered e-mail id; by calling the support number **18004190250** or sending them a request on support@sahaj.co.in

The customer will receive OTP from these numbers.
