What is PAN?

Permanent Account Number, or PAN, is a 10-digit alpha-numeric unique identifier issued by the Income Tax Department to any person in the form of a laminated physical card. At present, individuals and registered business entities, including export businesses, are required to have a PAN Card

Importance of a Pan Card -

- As an identity proof, pan card service is a valid document proof
- IT Returns Filling, all individual and entities who are eligible for income tax are expected to file there IT returns - which requires a Pan Card
- For bank Drafts, Pay order and banker's cheque Pan Card is mandatory. With out pan card none of the bank work could be done



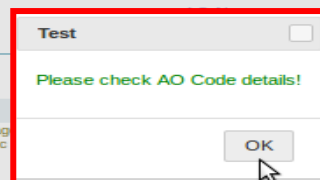
